The regular meeting of the Board of Directors of Southwestern Electric Cooperative, Inc. was held on Wednesday, March 2, 2022, at 5:00 p.m. at the office of Southwestern Electric Cooperative headquarters in Greenville, IL pursuant to notice given. President Ann Schwarm called the meeting to order and led in the Pledge of Allegiance to the flag.

MISO calculated required capacity for SWECI 2022-2023 forecast year is 118.8MW. We need to purchase 9.8MW capacity to meet the requirement. After discussion, the board agreed to purchase the additional capacity needed from the MISO auction.

Membership Applications and Terminations

January's list of membership applications and February's list of terminations were sent to the board prior to the meeting.

A motion was made by Nevinger, seconded by Stine, and carried to accept 66 applications for membership for January 2022, in accordance with Section 2 of the bylaws.

A motion was made by Warner, seconded by Gaffner, and carried to formally acknowledge the termination of 19 memberships for February 2022, effective as of the date on which the cooperative ceased furnishing services, and the release of capital credits to the members' estates totaling to \$40,189.46.

Unfinished Business:

Policy & Bylaws Committee chairperson Sandy Nevinger asked the board to look over the bylaws before the end of March for any recommended revisions.

New Business:

The board agreed to keep the CRC voting delegate as Williams and alternate as Schwarm for the 2022 CRC Board of Directors election.

Williams presented Warner with his Credentialed Cooperative Director Certificate. The board congratulate Warner on the achievement.
