The regular meeting of the Board of Directors of Southwestern Electric Cooperative, Inc. was held on Thursday, July 25, 2024, at 6:30 p.m. at the office of Southwestern Electric Cooperative headquarters in Greenville, IL pursuant to notice given. President Jerry Gaffner called the meeting to order and led in the Pledge of Allegiance to the flag.
